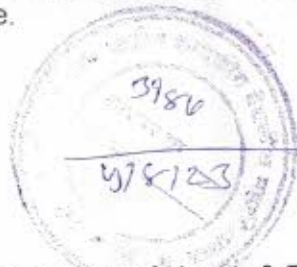

In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Recognition against increased intake of MS(Otorhinolaryngology) qualification for 02 (01 to 02 & 02 to 03) seats in respect of students being trained at Shri Vasantrao Naik Govt. Medical College, Yavatmal under Maharashtra University of Health Sciences, Nashik, Maharashtra**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:

- (i) The recognition so being granted herein, shall be valid for a maximum period of 05 (five) years from the year 2022, upon which it shall have to be renewed.
- (ii) The procedure for 'Renewal of Recognition' shall be same as applicable for the award of recognition.
